Jennifer spent more than 14 years successfully representing equipment and product manufacturers, distributors, suppliers, and contractors in multiple-party complex litigation, and she participated in all aspects of case management, discovery, law and motion, and trial preparation. She also assisted trial counsel on trials and served as second-chair during the lengthy trial of an asbestos mesothelioma case that ultimately resulted in a defense verdict for the client.

REPRESENTATIVE SUCCESSES

- Served as second-chair at trial and successfully secured a defense verdict on behalf
 of a large manufacturer of joint compound products in an asbestos mesothelioma
 case.
- Successfully obtained summary adjudication on behalf of a valve manufacturer with respect to plaintiff's claim under the California Superfund Act (Hazardous Substances Account Act) in a complex groundwater contamination case.
- Secured a dismissal for a large supplier of construction-related materials in an asbestos-related personal injury mesothelioma case. During the deposition of the plaintiff's primary product identification witness, the deponent recanted his prior testimony that implicated the supplier during cross-examination.
- Secured a dismissal for a large retailer of construction products in its first and only asbestos-related lawsuit (wrongful death lung cancer case) without having to respond to discovery or produce a corporate representative for deposition.
- Secured a dismissal for a large distributor of waterworks materials in an asbestosrelated personal injury mesothelioma case after preparing a motion for summary judgment, which plaintiffs' counsel determined they could not successfully oppose.
