REPRESENTATIVE SUCCESSES

- Obtained summary judgment in a personal injury asbestos-related matter filed in Alameda County Superior Court. The grant of summary judgment, a rare win in asbestos cases where there is affirmative identification of the client, came after a successful argument against plaintiffs' assertion that the client's product contained asbestos during the relevant time period. The court sustained Walsworth's objections to plaintiff's key percipient witness, and corporate representative testimony, and granted summary judgment.
